All models are single shift devices, denoted by the classification symbol NR, and some meet the clogging option requirement of EN 149, denoted by the classification symbol D, see EN 149 Classification Table.

The DS7810N, DS7812N, DS7820N, DS7822N, and DS7322N ranges make use of the same filter media, and the same design of nose clip and head straps. The DS7322N range include a carbon layer in the filtering media. Models DS7812N, DS7822N and DS7322N have the same design of exhalation valve. The masks are held in place by a pair of elasticated head straps. All ranges are classified as both FFP1 and FFP2.

The DS8732D model make use of the same filter media and the same design of nose clip and head straps. The model includes an exhalation valve of the same design. The masks are held in place by a pair of elasticated head straps with 'pull-through' adjusters.
