Manufacturer's Technical Specification

The manufacturer's Technical Specification for clothing for the end use of protection from the thermal hazards of an electric arc was based on IEC 61482-2:2009 "Live working – Protective clothing against the thermal hazards of an electric arc – Part 2: Requirements". The materials and garments were assessed according to IEC 61482-1-1:2009 "Live working – Protective clothing against the thermal hazards of an electric arc – Part 1-1: Test methods – Method 1: Determination of the arc rating (ATPV or $E_{\rm BT50}$) of flame resistant materials for clothing" and IEC 61482-1-2:2007 "Live working – Protective clothing against the thermal hazards of an electric arc – Part 1-2: Test methods – Method 2: Determination of arc protection class of material by using a constrained and directed arc (box test)". The suitability of these standards was checked with respect to the Basic Health and Safety Requirements of EC Directive 89/686/EEC, and were found to address the requirements for this end use.

The garments listed above are technically beyond the scope of IEC 61482-2:2009, however these items are made from material conforming to EN 61482-1-1:2009, EN 61482-1-2:2007 and IEC 61482-2:2009. In the opinion of BTTG Testing & Certification, these items meet the Basic Health and Safety Requirements of EC Directive 89/686/EEC and are suitable for the end use of protection from the thermal hazards of an electric arc, when worn in conjunction with garments offering full coverage and conforming to IEC 61482-2:2009.

Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The Balaclava was available in one size only which did not conform to the requirements of EN ISO 11612:2015, which refers to ISO 13688. It is constructed of a knitted fabric which should allow the item to conform to the wearer, and to be stretched back to its original size and shape. In the opinion of BTTG Testing & Certification Ltd, the size provision for this garment fulfils the requirements of Annex II, Clause 1.3.1 of Directive 89/686/EEC.

- 3. The client must implement appropriate changes as notified by BTTG.
- 4. The client must ensure the certified product is representative of the ongoing manufactured product.
- 5. The client must investigate complaints associated with the certified products. Records of such complaints, and actions taken, must be kept by the client and made available to BTTG when requested.
- 6. The client must only make claims consistent with the scope of certification,
- The client must not make any misleading or unauthorised comments regarding the certified product or the certification body.

Use of Notified Body Number

- 2. Use of BTTG Notified Body Number does not extend to other companies which are:
