Work shorts with waist band equipped with loops, closed by means of plastic button, front opening with zipper covered by placket, reinforcement on front crotch, no. 2 shaped welt pockets at hips, no. 1 patch pocket on back left-hand side closed by means of touch-andclose fastener tape, no. 1 shaped patch pocket on the back righthand side with flap fixed by means of touch-and-close tape, loop for use as tools holder on right hip, manufactured in fluorescent fabric and in non-fluorescent fabric at waist, in some parts of hip pockets and for the loop for use as tools holder, with no. 3 retroreflective bands of cm. 5 wide encircling legs.
